

# FIXED-TERM PART-TIME STIPENDIARY LECTURESHIP IN HISTORY FROM 1 SEPTEMBER 2024

The College invites applications for this post, which is tenable for a fixed period of 11 months from 1 September 2024 to 31 July 2025 based in New College, Oxford. The person appointed will be expected to provide tutorial teaching for six hours per week over the three academic terms, and to provide administrative and pastoral support for the cohort of undergraduate and graduate History students.

### 1. The College

Founded in 1379, New College is one of the oldest and largest of the colleges of Oxford University. The colleges are independent, self-governing establishments which function both as academic institutions and as social and residential centres for students and academics. New College currently has approximately 420 undergraduate and 350 graduate students, studying most of the subjects offered by the University of Oxford.

Undergraduate teaching at New College is organised and provided by around 35 Tutorial Fellows (nearly all of whom also hold University posts), assisted by about 23 Stipendiary Lecturers (college tutors employed on a fixed-term basis). There are also 15 Professorial Fellows and, at any one time, about 20 Junior Research Fellows. All these categories are members of the Senior Common Room, which provides dining and social benefits. Governing Body, which has overall responsibility for all aspects of the running of the College, comprises the Warden (the Head of the College) together with the Official Fellows.

## 2. History at New College

New College has a strong reputation in the field of History. The Tutorial Fellows in this area are Professor David Parrott and Dr Alexander Morrison (who will be on leave and replaced by the appointee for 2024-25), supported by the Stipendiary Lecturers, Dr Ruth Percy and Professor Christopher Tyerman. There are approximately 35 undergraduates studying for degrees in History and History joint schools. In addition there are approximately 15 graduate students reading for higher degrees in History.

#### 3. Details of the Advertised Post

## 3.1 Duties

The lecturer will be expected to teach six hours of tutorials per week during term-time. They must be willing to teach:

First Year Courses:

- EWP 4 Europe 1814-1914
- Approaches to History Anthropology and Sociology.

#### FHS Courses:

- EWF 10 The European Century 1820-1925
- EWF 11 Imperial and Global History 1780 1930
- EWF 13 Europe Divided 1914-1989
- EWF 14 The Global 20th Century 1930-2004
- Some elements of the course Disciplines of History

An ability to teach EWF 7 *Eurasian Empires 1400-1800* at Final Honour School level would be desirable but is not essential.

The candidate will also be expected to help out with the undergraduate admissions process in Michaelmas term, and to provide general support for student administration and welfare. They may be asked to act as college advisor for Masters students in College. They may be asked to examine theses or exam papers by the Faculty

#### 3.2 Qualifications:

The Fellowship is open to those who already hold a doctorate in history, or who will submit their doctorate at latest by summer 2024.

# 4. Salary and Conditions

The post carries a stipend of £16,166. (subject to review). The appointment will be pensionable under the USS scheme, details of which are available here: https://www.uss.co.uk/.

In addition, tutors are entitled to free lunch and dinner at the common table when this is available. In addition, the postholder will be entitled to use a research and teaching account (£1,405), and an entertainment account (£280).

The appointment will be for a fixed period of 11 months (September 2024 – July 2025) without possibility of renewal.
