

## **Privacy notice for outreach events with New College, Oxford**

### **Data protection**

In the course of completing this registration form, you have provided information about yourself ('personal data'). We (New College) are the 'data controller' for this information, which means we decide how to use it and are responsible for looking after it in accordance with the UK-General Data Protection Regulation (UK-GDPR) and associated data protection legislation.

### **How we use your personal data**

We will use your personal data to register you as a participant in a New College, Oxford outreach event.

Using your personal data in this way is necessary for a task that we carry out in the public interest (i.e. running events to promote access to Higher Education) and to meet our legitimate interests in promoting applications to the University.

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another related reason and that reason is compatible with the original purpose. If we need to use your personal data for an unrelated purpose, we will seek your consent to use it for that new purpose.

### **Who has access to your personal data?**

Access to your personal data within the College will be provided to those who need to view it as part of their work in carrying out the purposes described above. Access will also be provided to any third parties that we use to help organise outreach events with New College, Oxford. Where we share your personal data with a third party, we will seek to share the minimum amount necessary and ensure that any data sharing is done in compliance with the law.

We will add your personal data to the Higher Education Access Tracker service database (HEAT [www.heat.ac.uk](http://www.heat.ac.uk)), which we use to record information about our outreach activities and those who take part in them. HEAT is a shared database used by HEAT Service members to identify which activities are most helpful in preparing students for higher education and progressing to employment. Members include the University, its colleges, other Higher Education Institutions, and relevant public bodies (e.g. UCAS). The data added to HEAT comprises your personal details (name, gender, ethnicity, date of birth, disability status, postcode, school), and the events or activities in which you have participated. If you consent for your data to be entered on HEAT, you are also giving permission for your data to be monitored and tracked over time, in line with the time-frames set out in this privacy notice. Your personal data will never be used for marketing purposes, shared, or sold. The HEAT Service processes data solely for the monitoring and evaluation purposes described herein. Results are presented in an aggregate form without disclosing specific detail on individuals. We may also add your personal data to JISC. JISC is a not-for-profit UK-based organisation. They provide digital infrastructure to the education sector. We most often use JISC for conducting surveys. ### **Parental Email Addresses**

If your child is participating in New College's Step-Up Programme, you will be invited to join a parental newsletter emailing list. Your email address will be used for informing you about opportunities that may support your child's application to the University of Oxford, as well as information relating to New College's Step-Up Programme. We will also contact you to outline how parents can support a child who is applying to the University of Oxford. Emails will be stored on the College's system and in accordance with our UK-

GDPR policy, as outlined in this privacy notice.

Your email will only be stored for the length of time that your child is taking part in the Step-Up Programme. For most parents, this will mean that your email address will be deleted after they have finished Year 13 of their education.

You will complete an online form to enrol on the mailing list, which will use JISC to collect your data. Please read through the information on JISC, as outlined in this privacy notice. ### **Retaining your personal data**

We will only retain your personal data for as long as we need it to meet our purposes, including any relating to legal, accounting, or reporting requirements.

After completing your data entry form on JISC, it will be downloaded as an Excel spreadsheet. The information you have shared will then be uploaded to HEAT and stored in accordance with their retention policy. The original JISC form and downloaded Excel spreadsheet will be deleted following the upload to HEAT and will not be kept longer than is required on the New College system.

By completing the initial form, you are giving your consent for this information to be stored but note that the College will not retain the record of consent as the spreadsheets will be deleted upon uploading to HEAT. Should you wish to have your personal data removed from HEAT, please follow the instructions as laid out in 'Your rights' section below.

### **Where we store and use your personal data**

We store and use your personal data on College premises, in manual and electronic form.

Electronic data may be transferred to, and stored at, a destination outside of the UK.

Such transfers will only take place if one of the following applies:

- the country receiving the personal data is considered by the UK Government to provide an adequate level of data protection;
- the transfer is governed by either an International Data Transfer Agreement or EU approved contractual clauses supplemented by the UK Addendum;
- the transfer is based on your consent;
- the transfer is necessary for the performance of a contract with you or to take steps requested by you prior to entering into that contract; or
- the transfer is necessary for the performance of a contract with another person, which is in your interests.

### **Your rights**

You have rights under the data protection legislation to:

- **Request access** to your personal data (commonly known as a "subject access request"). This enables you to request a copy of your personal data and to check that we are lawfully processing it.
- **Request correction** of your personal data. This enables you to ask us to correct any incomplete or inaccurate information we hold about you.
- **Request erasure** of your personal data. This enables you to ask us to delete or remove your personal data under certain circumstances, for example, if you consider that there is no good reason for us continuing to process it. You also have the right to ask us to delete or

remove your personal data where you have exercised your right to object to processing (see below).

- **Object to processing** of your personal data where we are relying on our legitimate interests (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your personal data for any direct marketing purposes.
- **Request the restriction of processing** of your personal data. This enables you to ask us to suspend the processing of your personal data, for example, if you want us to establish its accuracy or the reason for processing it.
- **Request the transfer** of your personal data to another party.
- **Object to any automated decision-making** where decisions are made solely based on automated processing, including profiling, and which impact your legal rights or other equally important matters.

Depending on the circumstances and the nature of your request it may not be possible for us to do what you have asked, for example, where there is a statutory or contractual requirement for us to process your personal data and it would not be possible to fulfil our legal obligations if we were to stop. We will seek to deal with your request without undue delay, and in any event in accordance with the requirements of the UK-GDPR. Please note that we may keep a record of your communications to help us resolve any issues which you raise.
